- The Class B ordinary shares held by the reporting person are subject to forfeiture if the reporting person is removed as a director, or voluntarily resigns the reporting person's position with the issuer before a merger, share exchange, asset acquisition, share purchase, reorganization or similar business combination involving the issuer.
