\* PWAM is the investment manager to PWIMF and Park West Partners International, Limited, a Cayman Islands exempted company ("PWPI", and together with PWIMF, the "PW Funds"). Mr. Park, through one or more affiliated entities, is the controlling manager of PWAM.

As of December 31, 2023, PWIMF held 2,167,323 shares of Common Stock and warrants ("Warrants") to purchase up to 531,522 shares of Common Stock and PWPI held 249,955 shares of Common Stock and Warrants to purchase up to 68,583 shares of Common Stock. The Warrants are currently exercisable within 60 days of this report. As a result, PWAM and Mr. Park are deemed to beneficially own the shares of Common Stock underlying the Warrants. As of December 31, 2023, PWAM and Mr. Park may be deemed to beneficially own 3,017,383 shares of Common Stock of the Issuer held in the aggregate by the PW Funds.

The reported beneficial ownership percentage is based upon approximately 43,176,577 shares of Common Stock issued and outstanding as of November 9, 2023, based on information included in the Quarterly Report on Form 10-Q filed by the Issuer on November 14, 2023.
